The purpose of this deliverable, the **NEXUS-NESS Ethics Issues Management Plan (EMP)** is to assist the Consortium partners to deal with ethical issues that will or may arise in the context of NEXUS-NESS Project. It is developed primarily for internal use within the Consortium, but it may serve the extended network of NEL stakeholders and all actors involved into the WEFE Nexus mainstreaming strategies in the four countries where case studies (i.e. Living Labs of Nexus-Ness) are developed.

2. Introduction

In line with Responsible Research and Innovation ("RRI") principles, the project intends to produce socially acceptable outcomes of its innovation processes ensuring fair and sustainable allocation of resources, mitigation of conflicts and inclusive transition towards Water-Energy-Food-Ecosystems (hereinafter – "WEFE") Nexus approach.

One of the core elements of the NEXUS-NESS project is the co-production and co-testing of the WEFE Nexus management plans in collaboration with local stakeholders engaged in four living labs in Italy, Spain, Tunisia and Egypt.

The Project will engage local stakeholders as important actors and co-creators of NEXUS-NESS solutions by deployment of transdisciplinary and participatory approaches and the RRI Roadmap¹ with its Ethics and Gender dimensions.

The present EMP reflects the Consortium's commitment to conduct RRI "**With and For society**". It is designed to ensure the NEXUS-NESS compliance with the ethics requirements and relevant national and European law, international conventions, applicable codes of conduct and the requirements of the Grant and Consortium Agreements.

The EMP identifies and addresses the **main ethical issues** that may arise in the context of the NEXUS-NESS project, in particular, impacting:

- the decision making and workplan development process of NEXUS-NESS;
- the **participation of citizens and other stakeholders** in meetings as well as on-site in relation to innovation processes, data collection, processing and storage and personal data protection
- and any **general or specific ethical issue affecting the implementation of the project's activities** especially in non-EU countries and fair sharing of generated benefits with them, fair allocation of resources, gender balance and other inequality issues relevant for the project, as well as intellectual property rights.

The document is organized as follows:

- Section 3 describes the main ethical principles to be followed by the Project.
- Section 4 provides a summary of the policy and legal framework related to the ethical aspects of the project.
- Section 5 describes the general management procedures adopted within the Consortium to ensure NEXUS-NESS compliance with ethics and legal requirements.
- Section 6 explains how key ethical issues will be addressed during the project implementation.
- Section 7 will be further developed as the project evolves and specific challenges and ethical issues arise within the Nexus Ecosystem Labs (hereinafter "NELs").

As a living document, it will be updated whenever necessary. From the workplan it is stated for D1.3 "M6 and periodic updates as needed".

Relation to other deliverables and milestones

The present EMP relates to other NEXUS-NESS deliverables, including:

- *D1.1 (Project Management Plan)* which describes the management structure of the Consortium, including the role of the External Ethical Committee (hereinafter "EEC");
- *D1.3 (Data Management Plan)* which includes information on overall data collection and management procedures within the project;
- D2.1 (NEL EIA Methodology);
- D2.2 (NEL EIA Report);
- D2.3 (Gender dimension for Nexus Ecosystem Lab Innovation Ecosystem) which highlights how each NEL handles the gender dimension in the NEL activities and involved organisations;

The milestones which are of particular relevance for this EMP are as follows:

- *M1.1 Governing bodies established and functional,* including the External Ethical Committee (hereinafter "EEC");
- M2.1 NEL Ecosystem Innovation Master Class completed;
- M2.2 Satisfaction target for gender inclusion and balance across stakeholder achieved.

The combination of the aforementioned documents, including the present Ethics issues Management Plan, guarantees that all ethical issues are duly addressed in the project.

3. Ethical Principles

Innovation processes in NEXUS-NESS will be fully compliant with the ethical principles foreseen in Article 19 of *Regulation (EU) 1291/2013 of the European Parliament and of the Council of 11th December 2013, establishing Horizon 2020, - the Framework Programme for Research and Innovation (2014-2020)², articles 13 and 168 of the Treaty on the Functioning of the European Union (hereinafter - TFEU).*

In accordance with the aforementioned articles, NEXUS-NESS pays a particular attention to the following principles and ethical aspects:

- principle of **proportionality**;
- the right to **privacy**;
- the right to the **protection of personal data**;
- the right to the **physical and mental integrity of a person**;
- the right to **non-discrimination**;
- the need to ensure **high levels of human health protection**.

The NEXUS-NESS innovation activities and their results have an exclusive focus on civil applications.

All activities within the NEXUS-NESS project are implemented in line with the basic principles of *reliability*, *honesty*, *respect and accountability* envisaged by the European Code of Conduct for Research Integrity (ALLEA - the European Federation of Academies of Sciences and Humanities)³.

The project meets the **reliability principle** by ensuring the quality of research and innovation activities, reflected in the design, the methodology, the analysis and the use of resources.

In accordance with the honesty **principle**, developing, undertaking, reviewing, reporting and communicating of the project and its results will be carried out in a transparent, fair, full and unbiased way.

In addition, NEXUS-NESS ensures **respect** for colleagues, research participants, society, ecosystems, cultural heritage and the environment and **accountability** for the project activities from idea to publication, for its management and organisation, for training, supervision and mentoring, and for its wider impacts.

4. Policy and Regulatory framework

It is important to note that ethics compliance are among contractual obligations of the Consortium partners. As foreseen in *Article 34* of the Grant Agreement (hereinafter – the "GA") the Consortium members must ensure the project's compliance with ethical principles, the highest standards of research integrity and applicable international, EU and national law.

Along with ethical principles (see Section 3 of this deliverable) all NEXUS-NESS activities will comply with the Charter of Fundamental Rights of the European Union, the European Convention on Human Rights (and its Supplementary Protocols), EU Regulation 2016/679 on data protection (hereinafter - GDPR)⁴, and the European Code of Conduct for Research Integrity, EU legislation and strategic plans on gender equality and other relevant national, Union and international law.

Respect for cultural, religious and linguistic diversity, non-discrimination, equality between women and men, environmental protection, respect of the rights of persons with disabilities, the right to personal data protection and other human rights specified in the *Charter Of Fundamental Rights Of The European Union*⁵ are crucial for successful implementation of NEXUS-NESS in accordance with the RRI Roadmap.

The human rights envisaged in the *European Convention on Human Rights and its Supplementary protocols*, including the right to respect for private and family life (Article 8⁶), are also of fundamental importance for the project and NEXUS-NESS will respect them, in particular while implementing activities regarding personal data collection and processing during the project capacity building and other NEL workshops, development and exploitation of the multi-stakeholders user platform among others activities.

All the requirements of the *EU Regulation n.* 679/2016 (hereinafter – "GDPR")⁷ applies to the data processing in NEXUS-NESS as well.

NEXUS-NESS will follow good practices specified in the *European Code of Conduct for Research Integrity*⁸. It will also avoid any violations of research integrity, including research misconduct and other unacceptable practices foreseen in the European Code of Conduct for Research Integrity⁹.

The NEXUS-NESS Consortium partners will respect *EU legislation and strategic plans on gender equality*, including the EU Gender Equality Strategy 2020-2025¹⁰.

NEXUS-NESS will also contribute to the achievement of the goals of the United Nations 2030 Agenda for Sustainable Development and the European Green Deal.

In addition to the aforementioned international and EU law and policy documents and guidelines, NEXUS-NESS will respect the requirements of the applicable national law of the countries involved, both EU and non-EU countries (Spain and Italy as well as Tunisia and Egypt respectively), with regard to project's activities carried out on their territory.

5. Procedures to assure Ethics within NEXUS-NESS

The NEXUS-NESS management procedures include the establishment of a consortium body, the **External Ethical Committee (EEC), responsible for supporting the NEXUS-NESS governance and partners** in monitoring the project's compliance with relevant legal provisions and ethical requirements.

If necessary, the Consortium will seek the approval of the ECC prior to the beginning of relevant innovation activities. In addition, as foreseen in the GA, in case an activity raises an ethical issue, the Consortium partners must obtain:

- any ethics committee opinion required under national law;
- any notification or authorisation required under national and/or European law for the activities that raise the ethics issue.

5.1. External Ethical Committee (EEC)

The NEXUS-NESS governance structure includes the External Ethical Committee (hereinafter - the "EEC") in order to ensure the project 's compliance with relevant ethics issues, in particular by providing independent advice to the GEneral Assembly (hereinafter – the "GEA") and the Executive Board (hereinafter – the "EB") to adhere to ethics requirements.

The EEC consists of scientists and professionals with demonstrated expertise in ethical aspects, including gender balance and social inclusion issues, linked to topics and actions related to the NEXUS-NESS Project.

The EEC currently consists of:

- Johanna Koehler Assistant Professor of Environmental Policy & Governance, Vrije Universiteit Amsterdam, The Netherlands;
- **Gulnar Wakim** Specialist in the Arab Society and in the Situation of Women in the Arab World, Lecturer at the Lebanese American University and the Lebanese University, Lebanon;
- Sanaa Zebakh Researcher and international expert on agricultural research governance and science, Institut Agronomique et Vétérinaire Hassan II: Rabat, Morocco;
- Margaret Atosina Akuriba Department of Applied Economics, School of Economics and Management Sciences, University for Development Studies, Nyankpala Campus, Tamale, Ghana.

The members of the ECC will advise NEXUS-NESS on gender and other ethics issues during the project's lifetime. In particular, the EEC will:

- monitor the proper implementation of the present Ethics Issues Management Plan;
- review of the ethics related documents and deliverables;
- advice the Consortium partners and bodies regarding the ethics and gender dimension of interest for any direction, method, activity and outcome of the Project;
- participate in the Project events and provide feedback to the Consortium;
- provide inputs to the EB in relation to gender, social inclusion and other ethical issues related to the project. The project coordinator (UNISTRAPG) supported by partners in charge of tasks that coordinate ethics, NELs and innovation processes (UNIFI, SSSA and XPRO) prepares periodical report, as needed when/if ethical issues arise.

6. Key ethical issues

The key ethical issues that may arise during the NEXUS-NESS implementation are mainly related to:

- Stakeholders participation in Innovation Actions.
- Data collection and management, including the protection of personal data and privacy of the projects participants;
- Implementation of the Projects activities in Non-EU countries, namely Egypt and Tunisia;
- Assuring equal opportunities and addressing inequalities and vulnerabilities, with a particular reference to a gender dimension and fair allocation of resources;
- Intellectual property rights issues, including those related to authoring publications, proper acknowledgement and dealing with plagiarism.

6.1. Stakeholder engagement in Innovation Actions

6.1.1. Protocol for stakeholder engagement in Innovation Actions

NEXUS-NESS foresees the creation of four Nexus Ecosystem Labs (hereinafter - "NELs") located in Italy, Spain, Egypt and Tunisia and built on the Living Labs and RRI principles. Through the NELs, relevant regional and local stakeholders from all WEFE sectors (policy-makers and policy implementers, scientists, managers and technicians, farmers and food industry representatives, citizens as consumers) will be engaged following the RRI Roadmap, World Café and other participatory methodologies.

The stakeholders will be engaged in NEXUS-NESS through Mobilization and Mutual Learning participatory workshops (hereinafter - "MML") that will be organised face-to-face and online.

The main goal of the MML workshops is to collect information on the stakeholders' needs, goals and ideas about the current state of WEFE Nexus in their respective river basin and what is their vision for the future state WEFE Nexus.

In order to effectively engage all stakeholders, including the private sector and create long-lasting Innovation Ecosystems based on collaboration among academia, industry, different levels of the public sector and citizens, the Multi-stakeholder User Platform (hereinafter - "MSUP") will be also developed.

Thus, the stakeholders will contribute to the project mainly as:

- MML and other participatory workshops participants;
- MSUP users.

The following guidelines must be respected by each Consortium partner dealing with the stakeholders engagement:

- Participation of the NELs stakeholders in the NEXUS-NESS innovation activities must be on a *voluntary basis* and with a possibility to withdraw at any point. This is highlighted in the Informed consent template (Annexes 1-2) signed by project participants and stakeholders.
- *Gender responsive and socially inclusive approach* must be adopted while recruiting participants of the NEXUS-NESS workshops, in order to ensure the interests and guarantee equal opportunities to participate of every stakeholder. The Consortium will ensure that the stakeholders' engagement procedure is fair and that the diversity and non-discrimination principles are respected.
- *All four sectors (water, energy, food and ecosystems)* must be represented and engaged in the same workshops, including agencies and CSOs dealing with the preservation and management of ecosystems to fully cover each of the four dimensions of the WEFE Nexus.

The project activities and workshops are designed and implemented in such a way to ensure a trusting, respectful and equal environment for all stakeholders involved, none of the workshops will include any sensitive topics which might cause psychological stress, anxiety or humiliation, deception, or any potential increased danger to participants.

All project participants (including citizens and representatives of the organisations involved) must be provided with detailed information about the NEXUS-NESS project, its objectives and innovation activities, including the World café methodology, as well as the contact details of the Consortium team member responsible for the activity (a respective NEL Leader).

Specific procedures must be implemented to obtain *informed consents¹¹* to the terms and conditions of the project from participants of the surveys and other project activities, including the MML workshops. In particular, before the beginning of the MML workshops all participants will be asked to sign an informed consent form (Annexes 1-2), after being duly informed of the NEXUS-NESS project's activities and its objectives.

Participants will normally give their consent in writing (e.g. by signing the informed consent form and information sheets specified below). In accordance with the European guidance on Ethics¹², if consent cannot be given in writing, for example due to illiteracy, non-written consent will be formally documented and independently witnessed.

The informed consent form will explain the type of research and innovation activities and the entirely voluntary basis of the participation; therefore, no negative consequences are related to a withdrawal of the consent. Through the informed consent, all participants will be also informed on the use of their data, both personal and other data they contribute to the project, within the Project (For more details please see Section 6.2. of this Deliverable).

The informed consent form is accompanied with an *information sheet* which is an integral part of the informed consent form specified in Annexes 1-2. The informed consent explains in more detail the role of a person or an organisation in the project, the time required for participation in the project and other relevant information in order to make informed decision on whether joining the project or not, in particular:

- the list of the Consortium partners;
- expected outcomes of the project and overall workplan;
- risks and benefits of joining the project;
- storage and use of participant's data and information;

- confidentiality and anonymity issues;

- information on how to withdraw the project.

The information sheet is thought to be informative but brief in order to make the potential participants read it in full and understand it. It is intended to verify if participants understand that i) they are free to withdraw the project at any stage and their participation is voluntary, ii) they are free to ask any questions to the responsible project's representative(s), iii) the ways their data will be collected, processed, used and stored, and who will have access to the data they provided, iv) the data they shared will be de-identified.

To ensure better understanding of the project's activities, expected outcomes and the stakeholder's roles, the brochures will be developed specifically for each NEL in the **stakeholder's languages** (*not only native languages but also considering multi-sector and multi-actors involved, thus using the local language and the technical level that is clear for anyone reading/using it*). The textual part of the brochures has a visual support with pictures and illustrations not only guaranteeing the visual identity of the project but also enhancing the informative function of the brochures and facilitating the understanding of the project by stakeholders.

The template for informed consent with information sheets for MML and other NEL workshops participants and interviewees is provided in Annexes 1-2 to the present EMP and in its future updates.

Additionally, the project will use **questionnaires** asking the stakeholders involved (farmers, water managers, food sector businesses, local policy-makers and implementers) to provide information needed for the project successful implementation, in particular on farming agronomic practices, technology and personnel involvement. Any survey, including online one, in NEXUS-NESS should be accompanied by information presenting the Consortium and explaining the project, its purpose and potential benefits in a foreword to the questionnaires.

A specific informed consent form will be developed for the MSUP, Open Geoportal and NNS users and published at the respective websites.

All the informed consent forms developed for the purposes of the project must be fully compliant with the GDPR requirements from the point of view of data processing (see more details on this in the Section 6.2 "Ethics issues related to data processing" of this deliverable).

The project will not directly involve children, youngsters or other people unable to give informed consent, though their interests will be ensured through the engagement of the civil society organisations working in the field of youth and social inclusion.

6.2. Ethics issues related to data processing

The data collected in the project will be wide-ranging, in particular environmental, socio-economic and institutional as well as related to personal data/information.

NEXUS-NESS has opted for the Open Research Data Pilot (please see Deliverable 1.3 "Data management plan" for more details), which aims to open most of the data produced by the project with minimal restrictions possible, while protecting sensitive and confidential data from unauthorized access and use.

The specific requirements regarding confidential information and the protection of personal data and privacy, including the GDPR provisions, will be duly applied in the project.

Therefore, there are 2 main ethical issues related to data management that potentially may arise during the project: i) *confidentiality of the information and data* contributed to the project by stakeholders and ii) *protection of personal data and privacy* of the project's participants acting on their own behalf or representing their organisations. The issues are analysed in Sections 6.2.1 and 6.2.2. respectively.

6.2.1. Confidentiality

It is expected that most of the required data is publicly available free of charge from governmental and nongovernmental sources, including Open data repositories. In the unlikely event that any data compiled is not intended for public use, it will be kept confidential by the project. In this case Article 36 of the GA applies.

With regard to the NELs' workshops, the confidentiality of information and data provided by stakeholders and their anonymity will always be respected, if requested by the stakeholders.

As a general rule, in order to create a trusted environment the project will apply the Chatham House Rule with the following guiding principle: "*share the information you receive, but do not reveal the identity of who said it*"¹³.

The Rule states as follows: "When a meeting, or part thereof, is held under the Chatham House Rule, participants are free to use the information received, but neither the identity nor the affiliation of the speaker(s), nor that of any other participant, may be revealed"¹⁴.

In line with the aforementioned rule, stakeholders participating in the NELs and sharing information using the MSUP (i.e. Nexushare as renamed in related deliverable/milestone reports) will be duly informed of the rule and that no statements will be attributed. In workshops and meetings statements of participants may be quoted or attributed only with their permission.

The participants will be provided with draft documents for their prior approval before any publication and be given the opportunity both in advance and after meetings to decide if they wish their comments to be attributed or not.

6.2.2. Protection of personal data and privacy

NEXUS-NESS pays a particular attention to the protection of personal data and privacy of the project's staff and participants.

In accordance with Article 8 of the *Charter Of Fundamental Rights Of The European Union*, everyone has the right to the protection of personal data concerning him or her and such data must be processed fairly for specified purposes and on the basis of the consent of the person concerned or some other legitimate basis laid down by law.

The project will respect this fundamental right through adoption of the specific technical and organizational security measures compliant with the GDPR requirements (Article 32¹⁵) in relation to the collection and processing of personal data in meetings, workshops, surveys, interviews, web-based solutions and digital platforms, capacity building, dissemination and other activities within NEXUS-NESS.

The project might use personal data generated or processed by electronic networks (e.g. data relating to 'cookies', internet usage or electronic network traffic), in such case, the compliance with the EU Directive on privacy and electronic communications must be ensured¹⁶.

The Consortium partners must ensure that "the data are properly protected, minimized, and destroyed when no longer needed"¹⁷. NEXUS-NESS will avoid unauthorized collection and/or (mis)use of personal data.

The GA also contains the Consortium partners' obligation to respect the requirements of applicable EU and national law on data protection while processing personal data (Article 39.2 of the GA). In accordance with the GA, all the personnel whose personal data are collected and processed within the project and by the PRIMA Foundation or the Commission will be duly informed.

For further details on data collection and processing in non-EU countries involved in NEXUS-NESS see also Section 6.3.3 of this deliverable.

Definition of personal data

The project will protect personal data, i.e. "any information relating to an identified or identifiable natural person" (Article 4(1) of the GDPR), against unauthorized access, modification and loss.

In accordance with the GDPR, "an identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person" ¹⁸ (Article 4 (1).

It is important to take into consideration Recital 26 of the GDPR which specifies that "to determine whether a natural person is identifiable, account should be taken of all the means reasonably likely to be used, such as singling out, either by the controller or by another person to identify the natural person directly or indirectly"¹⁹.

In particular, "personal data which have undergone pseudonymisation, which could be attributed to a natural person by the use of additional information, should be considered to be information on an identifiable natural person".

At the same time, the data protection principles envisaged by the GDPR does not "apply to anonymous information, namely information which does not relate to an identified or identifiable natural person or to personal data rendered anonymous in such a manner that the data subject is not or no longer identifiable"²⁰.

Types of personal data collected and processed by NEXUS-NESS

The project's activities may require collection of personal data from the NELs participants. Particularly, they may be asked the following information: name, contacts, type of employment, age, sex, type and level of education, work qualification, interests regarding the WEFE Nexus and project's activities and services. No personal data that is not necessary to achieve the goals of the innovation activities tasks will be collected.

The project does not collect or process any data related to special categories indicated in Article 9 of the GDPR, i.e. *data on racial or ethnic origin, political opinions, religious or philosophical beliefs, or trade union membership, genetic data, biometric data for the purpose of uniquely identifying a natural person, data concerning health or a natural person's sex life or sexual orientation*).

Additionally, the project does not foresee the processing operations related to profiling, automated decisionmaking, data-mining techniques, big-data analytics and artificial intelligence, which pose higher risks to the rights and freedoms of data subjects.

It is important to note that the project's activities do not include any tracking of participants (e.g. localization data and/or WAN data, such as IP or MAC addresses, etc.). However, "cookies" might be used in the project's website, the MSUP (including the Open Geoportal) and the NNS to help analyse how users use them. NEXUS-NESS may use services like Google Analytics in order to track how many people access the project's website and its digital solutions (the MSUP (including the Open Geoportal) and the NNS). All the project's web platforms will be compliant with the GDPR.

Technical and organisational measures to protect personal data

In accordance with the Article 32 of the GDPR, a set of measures will be adopted for different types of the NEXUS-NESS project activities and digital solutions to ensure:

(a) the **pseudonymisation and encryption of personal data** collected and processed during the project;

(b) measures ensuring the ability to ensure the ongoing confidentiality, integrity, availability and resilience of processing systems and services;

Protection of personal data and privacy will be ensured for functioning of the NNS, the MSUP websites and the Open Geo-information portal as well as for the NEXUS-NESS capacity building activities (Summer/Winter schools and MOOCs).

When choosing the specific measures, NEXUS-NESS will assess and take into account the risks of varying likelihood and severity for the rights and freedoms of natural persons. The detailed information on the measures will be reported in Section 7 in future updates of the EMP.

As a general rule, NEXUS-NESS will adopt anonymous codes for the personal identification and registration of correspondence between identity and code on a dedicated computer with limited access.

As foreseen in Article 39.2 of the GA, the Consortium partners will grant their personnel access only to data that is strictly necessary for implementing, managing and monitoring the project and the GA.

Where applicable in accordance with the Article 37 of the GDPR, Consortium partners will appoint a Data Protection Officer responsible for the project's compliance with GDPR rules on behalf of the partner.

Informed consent and privacy statements

Informed consent for data processing for the purposes of the project will be obtained from the participants of the project's NEL workshops, other events, and interviews. It also will be included in questionnaires with personal data published on the NEXUS-NESS website and the MSUP.



A privacy policy will be published on the project's, the MSUP and other websites (if any) developed for the purposes of the project regarding the use of Google Analytics services (or similar), "cookies" or other data generated or processed by electronic networks (if any). A dedicated service (e.g. Iubenda, Termly, TermsFeed) will be used for adhering to international/national standards for privacy policy.

Related templates of the Privacy policy will be presented in the Annexes in the updates of the present EMP.

Through the **informed consent templates**, according to the GDPR, each project's participant is duly informed of his/her rights to:

i) access his/ her personal data (Article 15 of the GDPR);

- ii) rectification of inaccurate personal data concerning him / her (Article 16 of the GDPR);
- iii) request the personal data to be erased from the database (Article 17 of the GDPR);
- iv) restrict processing of personal data for certain purposes (Article 18 of the GDPR).

In accordance with Article 4 of the GDPR, **data controller** means the natural or legal person, public authority, agency or other body which, alone or jointly with others, determines the purposes and means of the processing of personal data. The data controller within NEXUS-NESS is the Project Coordinator.

In order to ensure fair and transparent processing of personal data and provide data subjects with necessary information at the time when personal data are obtained, the Informed Consent template contains the information listed in the Article 13 GDPR, in particular:

i) the identity and the contact details of the data controller,

- ii) the contact details of the data protection officer, where applicable;
- iii) the purposes and the legal basis for personal data processing;
- iv) the recipients or categories of recipients of the personal data, if any;
- v) the period for which the personal data will be stored;

vi) the existence of the data subjects rights to withdraw consent at any time, to request from the controller access to and rectification or erasure of personal data or restriction of processing concerning the data subject or to object to processing as well as the right to data portability;

vii) the right to lodge a complaint with a supervisory authority.

Personal data protection shall be guaranteed also in the case of data transfer in non-EU (third) countries (see section 6.3.3. on this issue).

At the current stage of the project, there are two types of the informed consent template compliant with the GDPR rules: (i) for the **NEL workshops participants (Annex 1 to this deliverable)** and (ii) for **interview participants (Annex 2 to this deliverable)**.

For more information please see Section 6.1 and the Annexes 1-2 of this Deliverable.

6.3. Non-EU countries

Countries involved in the NEXUS-NESS project are Italy, Cyprus, France, Germany, Spain, Egypt, Tunisia.

NEXUS-NESS created 4 Nexus Ecosystems Lab (NELs) linked to real case studies that will work as WEFE Nexus living laboratories. Two out of 4 NELs will be set up in Italy and Spain and two in non-EU-countries, namely Egypt and Tunisia.

6.3.1. Ethics requirements for non-EU countries



All activities carried out in Egypt and Tunisia will have the same ethical and legal standards required for the European NELs, while respecting national laws and local culture.

6.3.2. Fair benefit-sharing with non-EU countries

Co-creation is the cornerstone of the NEXUS-NESS project. The success of the project highly depends on collaboration with the stakeholders, located both in and outside the EU, and their inputs, knowledge and data.

The benefits and results of the project's innovation processes and capacity building activities will be shared in a fair way with the non-EU project partners and local stakeholders (local authorities, researchers, civil society organisations, farmers and private sector and others) from Egypt and Tunisia.

All Consortium partners, including the partners from Egypt and Tunisia, are invited to participate in the partner's meetings, conferences and other events organised by NEXUS-NESS (both online and in person), including the General Assembly meetings.

For the purposes of face-to-face meetings and events, all the partners have a budget for travel and accommodation. Besides, NEXUS-NESS partners from non-EU countries must be provided with necessary assistance with visa related issues (invitations) by the organisation hosting a face-to-face meeting or event.

6.3.3. Transfer of data between EU and non-EU countries

The Consortium partners from Tunisia and Egypt will be in charge of data collection within the NELs and, when needed, of its transfer to the EU partners.

NEXUS-NESS activities within the Tunisia and Egypt NELs may require collection of personal data. However, no personal data will be transferred to or from Tunisia and Egypt as far as **all personal data will be de-identified before transfer of any data between EU and non-EU countries.**

6.4. Equal opportunities and addressing inequalities

As highlighted in UN WOMEN report "Turning promises into action: Gender Equality In The 2030 Agenda For Sustainable Development"²¹, gender equality is crucial for sustainable development and all the sustainable development goals (SDGs). Moreover, globally, women are key actors in water and food systems of the project's interest, and they are particularly exposed to the use of unsafe energy sources and to the degradation of ecosystems.

Recognising it, the project adopts a *gender responsive and socially inclusive approach* and addresses context-specific aspects of inequality and exclusion in the different EU and African NELs.

Along with the gender dimension, NEXUS-NESS will pay a particular attention to the issues related to *youth* and social inclusion, considering that gendered inequalities are *crosscut by intersectional disparities by class, caste, ethnicity, age, religion as noted in the IWMI's Gender and Inclusion Strategy 2020-2030*²².

NEXUS-NESS addresses *gender related issues* in the NELs through Task 2.3 "Integrating gender dimension into NEL Innovation Ecosystem" aimed at guaranteeing that a gender responsive and socially inclusive approach based on NEL Ecosystem Innovation is implemented in the NELs. Additionally, all components of the WP2 ("Multi-actor Innovation Ecosystem Approach and RRI") will have a focus on tackling and transforming deep-rooted gender norms, as well as other exclusion barriers and challenges.

The Project is aimed at providing solutions for *fair allocation of natural resources*, while ensuring environmental protection. NEXUS-NESS intends to collect WEFE Nexus needs, goals and ideas of relevant stakeholders, with an aim to further co-design and co-construct project activities with the stakeholders and the consortium partners, in accordance with the RRI Roadmap methodology through MML participatory workshops, providing the stakeholders with science-informed information and knowledge on how uneven use of resources can be mitigated.

In particular, the project foresees the development of an integrated socio-environmental and economic assessment of the multiple benefits of transitioning towards a WEFE Nexus approach with specific focus on methodologies for accounting for (in)equality and distributional impacts.

6.4.1. Gender dimension

Aim for *gender equality* is a contractual obligation of all the Consortium members. As foreseen in Article 33.1 of the GA the Consortium members must take all measures to promote equal opportunities between men and women in the implementation of the project.

These measures go in two directions: the achievement of a gender balance at all levels of personnel assigned to the action, including at the supervisory and managerial level and the inclusion of the gender dimension into the actions carried out at NELs level, as foreseen in Task 2.3.

With regards to gender balance, following the European Commission's Gender Equality Strategy 2020-2025²³ and the Strategy on gender equality in research and innovation policy (Horizon 2020) (hereinafter – "Strategy on gender equality in Horizon 2020"), gender balance is fostered in the NEXUS-NESS project team and the decision-making structure.

The decision-making structure within NEXUS-NESS complies with the targets indicated in the Strategy on gender equality in Horizon 2020, being the exploitation and the executive board formed by three male and three female members each.

Regarding the inclusion of the gender dimension into the activities of the NELs, the project will seek to capture and measure gender impacts with regard to WEFE dimensions. The project will generate data and information on challenges to and opportunities for more gender-responsive WEFE implementations by drawing on indicators outlined in the UN WOMEN Turning Promises into Action report and the UN Expert Group Meeting recommendations, respectively.

Following the recommendations of the "Interim Evaluation: Gender equality as a crosscutting issue in Horizon 2020²⁴", NEXUS-NESS considered the improvement of gender knowledge as a strategic objective for gender equality as a cross-cutting issue. This led to the implementation of a specific gender capacity-building, aimed

to avoid a lack of knowledge on gender issues among the project's team during the implementation of the action.

Understanding how to consider a gender perspective and perform gender and sex analysis is crucial to identify critical issues and raising awareness of gender equality among the stakeholders.

To summarize, gender balance measures within NEXUS-NESS include:

- gender balance monitoring;
- training for NEL Leaders, Task leaders and stakeholders on gender equality and social inclusion issues relevant to their role in the project, so they consciously identify and address these gaps in every population groups' capacities.
- The Consortium partners responsible for Gender dimension activities and tasks work directly with NEL Leaders encouraging them to adopt gender balanced approach in selecting stakeholders and organising workshops in the NELs.
- The NELs communities are being facilitated to incorporate gender balance approach. In particular, during NEXUS-NESS workshops it will be ensured that all participants of the NELs have an equal voice, thus, relevant facilitation measures will be taken to this end.

Gender balance monitoring will be implemented in the second half of the project through the identification of a set of quantitative and qualitative indicators related to:

- Gender representation in the consortium and its decision making structure;
- Vertical (gender representation at various levels of leadership) and horizontal (gender distribution across sectors of project work) participation of women in the project;
- Frequency of participation in project meetings;
- Gender composition of internal project governance structures;
- Gender balance in the public representation of the project at outreach events.

6.5. Intellectual Property Rights issues

All issues regarding the innovation management and intellectual property rights of the Consortium partners are addressed in the CA based on DESCA (Consortium Agreement Model) H2020 model and the GA.

All the Consortium partners must respect the rules specified in Section 8 and Attachment 1 of the CA as well as Articles 30 and 31 of the GA related to transfer of ownership and licensing of the results of the project and access rights to them respectively.

Section 9 of the CA regards Background and related Access rights.

Article 8.1 of the CA specifies that project's results are owned by the party that generates them. In case of joint ownership, the rules specified in Article 8.2. of the CA and Article 26.2 of the GA apply.

Most outputs, in particular those based on open data, are open access through a Creative Commons License. Proper citation of the project's public documents is requested. See the D1.3 Data Management Plan for more information.

The graphical materials (photos and illustrations) generated within the project are available to the PRIMA Foundation and the European Commission for reuse.

The NEXUS-NESS project will respect the European Code of Conduct for Research Integrity and avoid any violations of the research integrity related to intellectual property, including plagiarism.

Respect for the intellectual property rights of third parties and due acknowledgement of the project's contributors will be guaranteed by the following means:



- The publications process within the project will follow the **Vancouver protocol on publishing** ethics (e.g. on authorship) or the editorial guidelines such as in **PNAS** which states that "Authorship should be limited to those who have contributed substantially to the work".
- Before using materials protected by copyright or other intellectual property rights of third parties the Consortium partners must properly inform the Project Coordinator about it and obtain all necessary permissions to be able to use the materials within NEXUS-NESS. The respective obligations must be imposed to the partner's employees and suppliers.

7. Ethics challenges within the NELs

At the current stage of the project, NEXUS-NESS project team can provide first insights on challenges and issues regarding Gender dimension of the project that are reported in the Deliverable 2.3.

Furtherly, this section will report on the specific ethics challenges and issues in the NELs' development, related to:
